### OFFICIAL REGULATION

#### I. PURPOSE OF THE SYMPOSIUM

The International Symposium “**EduVision Global**” aims to promote education that inspires through the valorization of innovation, balance, and modern educational visions, facilitating the international exchange of best practices, academic collaboration, and the development of educational models adapted to the challenges and needs of contemporary and future society.

#### II. OBJECTIVES OF THE SYMPOSIUM

1. **To promote inspiring and modern education** through the international exchange of best practices, educational experiences, and relevant research in the field of education.
2. **To develop teachers’ professional competencies** through the integration of pedagogical innovation, digital technologies, and modern teaching-learning-assessment strategies.
3. **To disseminate academic and educational contributions** by publishing participants’ papers in the Symposium Proceedings, with ISSN
4. **To develop sustainable educational partnerships** between institutions, teaching staff, and education professionals from different countries around the world, in order to promote international collaboration and intercultural exchange.
5. **To encourage an educational climate** based on creativity, balance, inclusion, and adaptability, focused on shaping future generations.

#### III. THEME

The International Symposium “**EduVision Global**” promotes the exploration and valorization of modern educational perspectives focused on creativity, harmonious development, and adaptability, inspirational teaching approaches, innovative educational practices, and international collaborations that support the formation of generations prepared to meet the challenges of an ever-changing society.

#### IV. ELIGIBLE PARTICIPANTS

- **Teaching staff** from pre-university and university education (early childhood educators, primary teachers, secondary teachers, lecturers, assistant professors, university professors).
- **Educational and administrative personnel** (educational counsellors, school inspectors, school principals, academic managers) involved in the development, implementation, and evaluation of educational strategies at national and international level.



## V. STRUCTURE OF THE SYMPOSIUM

The symposium is structured into a single section dedicated to the dissemination of academic research and educational reflection in an international context:

**Scientific Papers and Educational Essays** — Articles and essays analyzing educational models, public policies, teaching strategies, and interdisciplinary research, with a focus on pedagogical innovation, digitalization, international collaboration, and the adaptation of education to the challenges of the 21st century.

- Teaching projects, supplementary materials, worksheets, questionnaires, presentations, and other educational tools will not be accepted.
- Papers must be submitted exclusively in **.doc/.docx** (Microsoft Word) or **.pdf** format. Other formats (e.g., .ppt/.pptx, images, etc.) will not be accepted.
- Paper length: **5 pages maximum**.

## VI. REQUIREMENTS FOR SUBMITTED PAPERS

Papers submitted for publication must fall within one of the established sections of the Symposium.

### Formatting Requirements:

- **Font:** Times New Roman, 12 pt
- **Spacing:** 1.5 lines
- **Length:** maximum 5 pages
- Papers must be submitted exclusively in **.doc/.docx** (Microsoft Word) or **.pdf** format. Other formats (e.g., .ppt/.pptx, images, etc.) will not be accepted

### Mandatory Structure of the Paper:

- **Title of the paper** – written entirely in uppercase letters and centered.
- **Author's/Authors' name(s) and institutional affiliation** – placed immediately below the title, right-aligned.
- **Complete bibliography**, drafted according to academic standards (author, title, publisher, city, year).

### Important Notes:

- The responsibility for the content and originality of the papers lies exclusively with the authors.
- Papers with a maximum of **two authors** are accepted; in this case, each participant must pay the registration fee and will receive all documents included in the “Teacher’s Package.”
- Papers must be submitted **online**, through the participant’s account on the website [www.edumanagement.institute](http://www.edumanagement.institute).



## VII. PACKAGES OFFERED TO PARTICIPANTS

To meet both the professional needs of participating teachers and the official requirements established by current legislation regarding continuous professional development, merit-based career advancement, and teacher mobility (Law No. 198/2023, Law No. 199/2023, Order No. 3251/2023 regarding merit grading, Order No. 3803/2023 regarding continuous training, and Regulation No. 15/2019 of Bulgaria), each participant will receive a personalized package of documents.

These documents are issued in **trilingual format** (Romanian, English, Bulgarian) and are recognized as supporting evidence for the professional portfolio.

### 1. Participant Package (Basic)

This package is designed for all participating teaching staff. It includes the essential documents required for the professional portfolio and for annual performance evaluation:

- **International Scientific Certificate of Participation** in the International Symposium *“Excellence in Modern Education through Pedagogical Innovation / Excelența în Educația Modernă prin Inovație Pedagogică / Превъзходство в съвременното образование чрез педагогически иновации”* issued in three languages;

All documents are issued in **trilingual format (EN/RO/BG)** and comply with current legal provisions.

- **Final deadline for registration and submission of materials:** 29 June 2026.
- **Issuance of digital documents:** from 1 July 2026 (available in the participant's account).
- **Dispatch of printed documents (Premium Package):** from 7 July 2026.
- **Symposium Journal (digital format, with ISSN):** available online from 7 July 2026.
